PAYMENTS & CANCELLATIONS

1. Terms of service: Senderodawa lists what is included in the important section.

2. Reservation: Your spot is reserved with a non-refundable deposit of \$600
The cancellation policy is listed below.

3. Payment: All prices are USD and per person. **A non-refundable deposit of \$600 will secure your spot, and the remaining balance will be due within 30 days of check - in date.**

Refunds and credits are available only according to conditions described below.
Payments will be made by credit cards, or apple pay , through our booking website.

4. Cancellations Policy & Deposits: We know life happens, things come up, people get sick, work throws you a curveball, we get it, we are human too. Cancel within 0-45 days of the check-in date: You are obligated to pay the entire trip cost, inclusive of the \$600 deposit.

CHANGES: Senderodawa reserves the right to make any changes deemed necessary by our team, trip leaders, teachers or partners. Senderodawa is not responsible for any expenses or damages incurred as a result of trip cancellation or postponement including preparation costs, airline tickets, travel documents or other expenses. INSURANCE

Travel Insurance:
